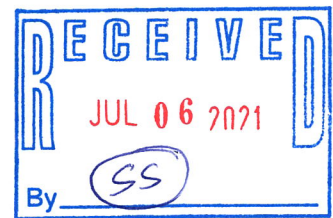

Dear Secretary Shamin:

We thank Milford Township for its recent input regarding the annual funding allocation for Emergency Medical Services (EMS). In addition to these funds, we have offered to pledge a County match of a municipality's EMS contribution of up to a maximum of 2 mils.

As we continue to work toward a solution to the EMS crisis in Pike County, we invite you to attend a presentation of our proposed plan and draft guidelines outlining how these funds could be distributed and used to expand EMS services.

**The presentation will be held on Tuesday, July 27, 2021 at 7:00 p.m. at the Pike County Training Center, 135 Pike County Boulevard, in Lords Valley.** This marks a location change from a meeting invitation you may already have received from Blooming Grove Township.

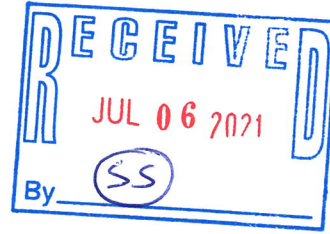
